By signing below, it is agreed by the Player and the Parent or Guardian (if the Player is a Minor) that the Player, and Parent or Guardian, agrees to indemnify and hold harmless the SAYM from any claims, demands, damages, injuries, costs, expenses, loss of services, actions and causes of action arising out of or sustained by the Player and/or the Parent or Guardian, as applicable, participating in the SAYM Softball League.

The Player, or the Parent or Guardian of the Player, hereby releases and forever discharges the SAYM and its coaches, managers, servants, agents, and employees from any and all actions, causes of action, claims, and demands for any injury, loss, or damage hereinafter caused or arising which may hereafter be sustained by activities or in connection with the game of softball given or sponsored by the SAYM.

This form must be completed in full and signed by the Player, and for players under 18 years of age by their Parent or Guardian before the Player will be permitted to play. No Player may participate in any SAYM game as a Player or Official without first completing this form in full and returning it to their coach or manager, and obtaining the coach's or manager's signature.

It is the responsibility of the coach or manager to have at all times this completed form available at every SAYM game, and to provide a copy of this form to the League Convener or Steering Committee upon request. These forms are to be returned to the SAYM Steering Committee at the end of the season, and may be used to aid in verification of the team list submitted for determining tournament eligibility.
